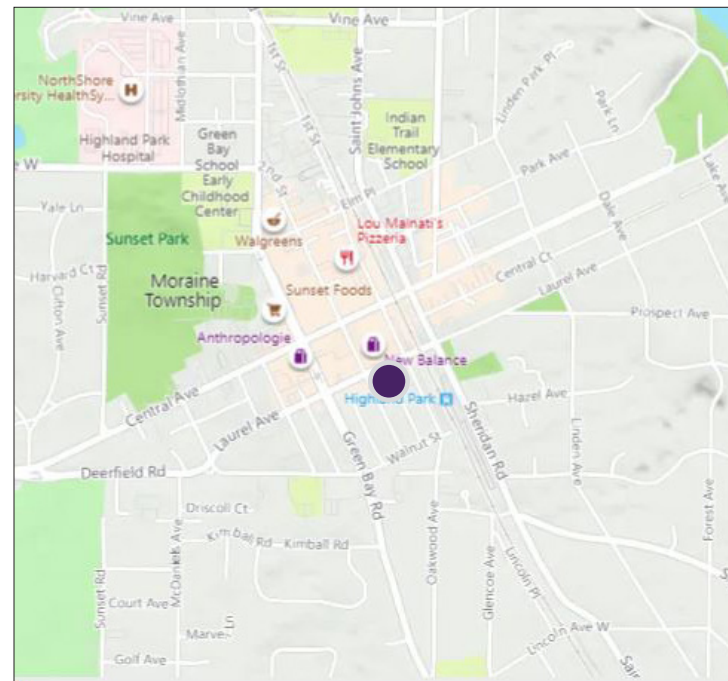

Property Overview

Available for lease is a 2,500 square foot office space in a 14,000 square foot mixed-use building. The unit was completely rehabbed in 2017 and is improved with two bathrooms, two kitchens, several offices and open space. The space can be easily divided into two separate, 1,250 square foot units. Retail in the area include DeNuccis Restaurant, Bluemercury, Target, Eileen Fisher, NIC + ZOE, Orangetheory Fitness, Lou Mainati's Pizzeria, Anthropologie, Sunset Foods plus a multitude of boutiques, dining and entertainment options. The property is well-located on Laurel, which is part of the Commercial Pedestrian Core.

Highland Park is an affluent suburb located in approximately 25 miles north of Chicago in the heart of the North Shore. This area is densely populated with an excellent average
