The business generates \$33,600 per year in rent. A 2,000 square foot storefront is available for lease and is perfect for retail or office. The property is located near busy Harlem Avenue and has great potential for a user or investor. Nearby businesses include Target, Ulta Beauty, Kohl's, Hobby Lobby, X-Sport Fitness, Culver's, Dollar Tree, several restaurants and shops.


